4. CANCELLATIONS & REFUNDS

- 5.5. **Disputes:** Any disputes regarding breakages will be resolved at the discretion of our management team.

* An invoice will be generated by the CEO or manager on site. The client is liable to settle this invoice within 5 days from the event date.
